VOORWAARDES:

- 1 n Lid sal slegs aankoopkaartbeveiliging geniet vanaf die datum dat hy/sy die diefstal of verlies van sy/haar aankoopkaart skriftelik by hierdie Koöperasie aangemeld het.
- 2 n Lid sal verplig wees om 'n beëdigde verklaring oor die omstandighede rondom die diefstal / verlies van die aankoopkaart by hierdie Koöperasie in te handig en aan enige ander vereiste wat die Koöperasie stel, te voldoen.
- 3 Die onus sal op die lid wees om, ingeval van ongemagtigde aankope op sy/haar aankoopkaart, die betrokke aankope te identifiseer en na skakeling met die betrokke leweransier waar die aankope gedoen is, voldoende bewys aan hierdie Koöperasie te lewer dat die aankope inderdaad ongemagtig was.
- 4 Geen beveiliging sal deur 'n lid geniet word indien die verlies van die aankoopkaart aan opset of growwe nalatigheid van die lid toegeskryf kan word nie.

CONDITIONS:

I accept that I will be safeguarded after the amount in respect of the Safeguarding Fund was debited to my account and paid by me and that the following conditions will also apply:

- 1 A member will be safeguarded from the date that the theft / loss of his / her purchase card is reported to this Co-operative in writing.
- 2 A member will be compelled to hand in an Affidavit to this Co-operative concerning the circumstances surrounding the theft / loss of the purchase card and must comply with any other condition set by this Co-operative.
- 3 Where unauthorised purchases were made on his / her card, the onus will be on the member to identify these purchase and after contacting the suppliers where the purchase were made, to provide sufficient proof to this Co-operative that the purchases were in fact unauthorised.
- 4 A member will not enjoy any Safeguarding if the theft / loss of the purchase card was intentional or due to gross negligence on the part of the member.
